



ETORO AUSTRALIA PROMOTION TERMS AND CONDITIONS

This document sets out the terms and conditions (Promotion T&Cs) that govern the promotion participants to receive 90% off the Annual Patreon deal with Suited & Booted when they join eToro using the Suited & Booted tracking link and make a first-time deposit (the Promotion). This promotion is run by eToro AUS Capital Limited AFSL 491139 ABN 66 612 791 803 (eToro). The Suited & Booted component of this Promotion is provided by Suited & Booted ABN 68 116 240 7 (Suited & Booted), separately and independently from eToro.

This Promotion does not constitute financial product advice. Any information provided in connection with this Promotion is general in nature only and does not take into account any participant's objectives, financial situation or needs. Participants should consider whether trading or investing is appropriate for them having regard to their own circumstances.

DEFINITIONS AND INTERPRETATION

1. Unless the context otherwise specifies, the following words and expressions shall have the meaning set out below:
 - a. Account or eToro Account means the Invited Participant account with eToro.
 - b. Allowable States/Territories means the following States and Territories: New South Wales, Queensland, South Australia, Tasmania, Victoria, Western Australia, Australian Capital Territory, Jervis Bay Territory and Northern Territory. eToro may amend the list of the Allowable States/Territories by adding or removing States/Territories at its sole and exclusive discretion.
 - c. Eligible Participants are defined in Section 4 below.
 - d. Invite means an invite to participate in the promotion by way of either: (i) an email sent directly by eToro, or (ii) advertisement tool facilitated by eToro.
 - e. Invited Participants means the individuals who receive the invite.
 - f. Offer means the offer as described in Section 17 below.
 - g. Promotion means the promotion as described in Section 9 below
 - h. Promotion Criteria means, the criteria for the promotional offer as described in Section 6 below.
 - i. Promotion Period is defined in Section 3 below.
 - j. Qualifying Participant means an Eligible Participant who meets the Promotion Criteria and receives the Offer.
 - k. Suited & Booted Offer means the 90% discount off the Annual Patreon deal with Suited & Booted provided under this Promotion.
 - l. Patreon Offer means the 90% off Annual Patreon deal with Suited & Booted benefit provided by Suited & Booted under this Promotion.

APPLICABILITY

2. Information on how to enter and the offer form part of these terms and conditions. Entries must comply with these conditions to be valid.

Participation in the Promotion is subject to applicable law and eToro's applicable terms and conditions.

PROMOTION PERIOD

3. The promotion will commence on 9 June 2026, and end at midnight on 31 December 2026 AEST (Promotion Period).

ELIGIBLE PARTICIPANTS

4. Entry is open to all people residing in Australia who:
 - (a) are over 18 years of age;
 - (b) have completed the registration to open an eToro account during the Promotion Period period;
 - (c) meet, accept and agree to eToro's T&Cs and the eToro Privacy Policy;
 - (d) must NOT be an employee of eToro or of an eToro subsidiary, parent company or a company under common control with eToro ("eToro Affiliates") and NOT an immediate family member (parent, sibling, spouse, child) or household member of an eToro employee, an employee of an eToro Affiliate, or a person involved in any part of the administration and execution of this Promotion;
 - (e) is a resident of Australia; and
 - (f) enters and submits their entry themselves.
5. Entry is only open to new eToro customers who open an eToro Account during the Promotion Period, unless eToro expressly states otherwise in writing.

Each person who complies with clause 4 above will be an 'Eligible Participant' for the purposes of these terms and conditions.

PROMOTION CRITERIA

6. Eligible Participants may enter the promotion by completing the relevant criteria as outlined below.
7. Entry into the promotion:
 - (a) complete the registration to open an eToro account during the Promotion Period (ending 31 December 2026); and
 - (b) meet, accept and agree to eToro's Terms & Conditions and Privacy Policy.

Note: This Promotion is not a draw, lottery, game of chance or competition. All Eligible Participants who meet the Promotion Criteria during the Promotion Period will receive the Offer.
8. Eligibility for the Suited & Booted offer:
 - (a) To qualify for the offer, participants must:
 - (i) be fully verified by eToro pursuant to its policies and procedures;
 - (ii) make a minimum deposit of USD \$50 into their eToro account; and
 - (iii) meet the above criteria during the Promotion Period.

Note: eToro's standard minimum deposit of USD \$50 applies. For the avoidance of doubt, making a deposit does not guarantee receipt of the Offer unless the participant meets all Promotion Criteria during the Promotion Period.

PROMOTION

9. eToro and Suited & Booted are not liable for any loss or damage (even if caused by negligence) as a result of any participant using the promotional offers, except for any liability which cannot be excluded by law.
10. Eligible Participants acknowledge that eToro and Suited & Booted make no promise or guarantee regarding the suitability of the promotional offers. Complaints relating to eToro's financial services will be handled in accordance with eToro's dispute resolution procedures. Complaints relating to the Patreon Offer should be directed to Suited & Booted, unless the complaint concerns eToro's administration of the Promotion.

QUALIFYING PARTICIPANT

11. All Eligible Participants who meet the Promotion Criteria during the Promotion Period will automatically qualify for the offer. No draw or random selection is involved.
12. An Eligible Participant can only receive the promotional offers once per Promotional Period.

NOTIFICATION OF QUALIFYING PARTICIPANTS

13. Qualifying Participants will receive an automated email from eToro within 24 hours of making their first deposit. This email will contain a discount code in which the participant must use on the Patreon membership process. This information will be shared with Suited & Booted ABN 68 116 240 7 for the sole purpose of providing the participant with a 90% discount code for the Annual Patreon deal, and with eToro employees for the purpose of administering the Promotion.
14. By providing your email, the Qualifying Participant consents to eToro collecting their full name and Patreon account email address and disclosing that information to Suited & Booted for the purpose of providing the Patreon Offer. Suited & Booted will handle that information in accordance with its own privacy policy. eToro will handle personal information in accordance with its Privacy Policy and applicable privacy collection notice.
15. The Patreon Offer will not automatically renew at the end of the annual promotional period unless the participant separately agrees renewal terms directly with Suited & Booted. Participants should review Suited & Booted's applicable terms before using the Patreon Offer.

OFFER DETAILS

16. All Eligible Participants, who meet the qualifying terms and conditions, and the Promotion Criteria during the Promotion Period, will be eligible to the offer detailed below.

Sign up to eToro via the Suited & Booted tracking link, be fully verified, and make a first-time deposit (minimum USD \$50 as per eToro's standard minimum).	90% off the Annual Patreon deal with Suited & Booted.

17. The offer is personal and non-transferable and shall apply solely to the eToro account for which the Promotion was made available.
18. The offer under this Promotion may only be granted once to an Eligible Participant.

19. The offer provided under this Promotion is for a Patreon subscription discount only and is not a financial product.
20. The offer is non-transferable and has no cash value.
21. The availability of the Patreon Offer under this Promotion is not a recommendation, endorsement or opinion by eToro or Suited & Booted regarding any financial product. eToro does not endorse or recommend any content provided by Suited & Booted.

PROMOTIONAL OFFER CRITERIA

22. All Eligible Participants who meet the Promotion Criteria during the Promotion Period will receive 90% off the Annual Patreon deal with Suited & Booted.
23. The Patreon discount code will be issued within thirty (30) business days after meeting the Promotion Criteria.
24. The issuance of the Patreon discount code will constitute confirmation that the participant has qualified for the Offer. eToro is not required to send a separate notification to these participants.
25. Participants who did not qualify:
 - (a) Participants who do not meet the Promotion Criteria during the Promotion Period will not receive the Suited & Booted Patreon offer.

PROMOTION SUBSTITUTION

26. In the event that any part of the Promotion becomes unavailable for reasons beyond eToro's control, eToro may, at their absolute discretion, substitute the Promotion (or the relevant part of the Promotion) with an alternative promotional benefit of equal or greater value, subject to applicable law.
27. The Suited & Booted Patreon offer is not redeemable for cash under any circumstances.

UNCLAIMED PROMOTIONAL OFFER

28. eToro will use its best endeavours to contact the Qualifying Participants of the Promotion via the Qualifying Participants' registered email address. However eToro will not be liable for the Qualifying Participants' failure to receive a qualification notification.
29. If participants fail to comply with the instructions in a written notification on claiming the promotional offers, they will not be entitled to the promotional offers.

USE OF ELIGIBLE ENTRANTS' PERSONAL INFORMATION

30. Personal information including Eligible Entrants' names, addresses and contact details will be collected and used for the purpose of conducting this Promotion. This includes sharing participants' names and Patreon account email addresses (submitted via the typeform) with Suited & Booted ABN 68 116 240 7 for the purpose of providing the Patreon discount code. This may also require disclosure to other third parties, including local regulatory authorities and eToro's agents or third-party service providers, for the purposes of conducting the Promotion (Purpose).
31. By entering this Promotion, the Eligible Entrants consent to the use of their personal information for the Purpose.
32. Eligible Entrants may access, change and/or update their personal information in accordance with eToro's privacy policy available [here](#). The privacy policy contains information about how individuals may access or correct personal information or make a privacy related complaint.

33. Participants should also review Suited & Booted's privacy policy before submitting their Patreon account email address, as Suited & Booted is responsible for its own handling of personal information once disclosed to it for the purpose of providing the Patreon Offer.

GENERAL CONDITIONS

34. eToro accepts no responsibility for late, lost or misdirected entries or other communications.
35. At any time, we reserve the right to cancel, change or suspend this promotion, subject to applicable law and provided that any such cancellation, change or suspension will not affect any rights already accrued by a Qualifying Participant unless required or permitted by law. .
36. All taxes and local government fees (excluding GST) that may be payable as a consequence of receiving the credit are the sole responsibility of the Qualifying Participants.
37. The offer is not valid in conjunction with any other promotions, discounts or promotional codes, unless stated otherwise.
38. eToro may terminate or cease this Promotion if the total value of the credits granted or paid under this Promotion reaches a certain threshold, as determined by eToro acting reasonably and subject to applicable law.
39. For clarity, eToro may decide to change any such threshold, including the maximum number of the potential Eligible Participants specified in section 17 above, at any time, subject to applicable law and provided that any such change will not affect Qualifying Participants who have already qualified for the Offer.
40. Participants consent to eToro and Suited & Booted using their participation details for promotional and marketing purposes in accordance with their respective privacy policies and applicable law.
41. Should an Eligible Participant's contact details change during the promotion period, it is the Eligible Participants responsibility to notify eToro. A request to access or modify any information provided as part of the redemption of an offer should be directed to eToro.
42. eToro may at their absolute discretion request verification of any personal information of Eligible Participants provided for the purposes of the promotion and arranging a credit.
43. eToro reserves the right to disqualify any individual who breaches these terms and conditions, submits an entry that is not in accordance with these terms and conditions, or who is involved in any way in interfering or tampering with the fair and proper conduct of this promotion. Failure by eToro to enforce any of its rights does not constitute a waiver of those rights.
44. By entering this promotion, Eligible Participants acknowledge and agree that these terms and conditions, the promotion and the consequences of receiving the promotional offer an experience and/or credit may be subject to the terms and conditions of third-party service providers such as social media platforms, video platforms, payment providers and transfer companies (Third Party Terms). eToro will not be liable for any damage or loss suffered by the Eligible Entrants in connection with such Third Party Terms, except to the extent such liability cannot be excluded by law.
45. Participants in the Promotion may have rights under the Australian Consumer Law and other similar legislation which cannot be excluded, restricted or modified by eToro. These terms and conditions do not exclude, restrict or limit those statutory rights in any way. However, to the maximum extent that it is permitted to do so by law, eToro (including its officers, employees and agents) excludes all liability whether arising in tort (including without limitation negligence), contract or otherwise for any personal injury or any other loss or damage (including without limitation loss of opportunity or loss of profits) whether direct, indirect, incidental, special or consequential, arising in any way out of the promotion, including, without limitation:
 - (a) any theft, unauthorised access or third party interference;
 - (b) any entry that is late, lost, altered, damaged or misdirected (whether or not after the receipt by the eToro) due to any reason beyond the reasonable control of eToro;

(c) any tax implications.

46. The offer or use of the offer:

(d) Eligible Participants and Qualifying Participants of the Promotion agree at all times to indemnify and hold harmless eToro and its officers, employees and agents (“those indemnified”) from and against any loss (including reasonable legal costs) or liability incurred or suffered by any of those indemnified where such loss or liability was caused by the Eligible Participants and/or Qualifying Participants or their officers’, employees’ or agents’:

(a) breach of any term of these terms and conditions; or

(b) negligent, fraudulent or criminal act or omission.

47. eToro will not be liable for performance delays nor for non-performance due to causes beyond their reasonable control. If the promotion is not capable of running as planned, eToro reserves the right to cancel, suspend or modify the Promotion , or amend these terms and conditions, unless to do so would be prohibited by law.

48. These terms and conditions are governed by the laws applying in Australia.
